President

Education Officer

Awards

Doctoral Student Award – We received 13 applications this year, it was extremely competitive so thank you for those applications. We have been able to award 5 awards and those will be presented this afternoon.

Doctoral Thesis Prize – We didn't receive any applications this year. This may be due to people's deadline dates changing due to covid.
